**Subject**: A resolution designating Joyce Boulevard from College Avenue to Crossover Road as the Honorary Jack Luper Boulevard.

## **PROPOSAL:**

On September 22, 2011, Jack Luper was fatally injured in the work zone after being struck by a vehicle, while working with his crew to repair a section of Joyce Boulevard.

Jack began his career with the City of Fayetteville in 1979 working in the Solid Waste Division. He later transferred to the Transportation Division and advanced to the position of Crew Leader with the asphalt overlay program where he continued to distinguish himself as a dedicated servant of the citizens of Fayetteville over the last 31 years.

It is the intent of the Transportation Division staff and City administration to honor the memory and faithful service of Jack Luper.

### **RECOMMENDATION:**

City staff and administration recommend a resolution for Joyce Boulevard from College Avenue to Crossover Road to be designated the Honorary Jack Luper Boulevard.

This change will be an honorary designation only and will have no impact upon addresses on Joyce Boulevard.

### **BUDGET IMPACT:**

The budget impact for the City of Fayetteville will be approximately \$250.00 for the installation of two new street signs.
