DONATION WARRANTY DEED WITH CONTROL OF ACCESS

KNOW ALL MEN BY THESE PRESENTS:

That the City of Fayetteville, Arkansas, Grantor, Lioneld Jordan and Sondra Smith, Mayor and City Clerk, respectively, by statute duly authorized so to act, for and in consideration of the mutual covenants and benefits inuring to the parties hereto, does hereby grant, bargain, deliver, quitclaim and donate to the Arkansas State Highway Commission, Grantee and unto its successors and assigns, the following land, together with all abutter's existing, future and potential common law or statutory rights of access between the herein described property and the Grantors' remaining abutting and contiguous land, but saving and excepting such minerals therein and thereunder, as oil, gas, distillate, condensate, salt water and its component parts, and all other hydrocarbons which do not interfere with the surface use for highway purposes, lying and being described as follows, to-wit:

Part of the Southwest Quarter of the Northeast Quarter of Section 26, Township 17 North, Range 30 West, Washington County, Arkansas, more particularly described as follows:

Commencing at a ½ inch rebar with cap 1466 being used as the southeast corner of Lot 17D of the CMN Business Park II, Phase II, Lot 17 Subdivision to the City of Fayetteville; thence South 40° 18' 38" West along the south line of said Lot 17D a distance of 37.42 feet to a point on the Northwesterly right of way line of U.S. Highway 71B (Fulbright Expressway) as established by AHTD Job 040535, for the POINT OF BEGINNING; thence South 76° 41' 21" East along said right of way line a distance of 45.91 feet to a point; thence North 53° 50' 19" East along said right of way line a distance of 99.13 feet to a point on the Northerly right of way line of U.S. Highway 71B (Fulbright Expressway) as established by AHTD Job 9447; thence South 40° 16' 51" West
