RECOMMENDATION

City Administration recommends approval of an ordinance for a cost-share and bid waiver in the approximate amount of \$98,949.00 with South Garland Boulevard Associates, LP for the upsizing from an 8" to an 12" proposed water main from Razorback Road to Rose Ave. and installing a 12" water main from Rose Ave. to Stadium Drive

BACKGROUND

South Garland Boulevard Associates, LP recently submitted a Large Scale Development LSD 12-4052 Park Green Collegiate View for approval by the City of Fayetteville. As a condition of approval for this proposed development, a water main is required to be extended from Razorback Road and Martin Luther King Blvd to the site meet fire flow requirements for the 15 acre multistory housing development. A 12" water main is required from MLK Blvd to the site via Stadium Drive and an 8" water main is required from Razorback Road via Indian Trail and Rose Ave. The 8" water main along Indian Trail is the size that is necessary to provide the secondary loop to serve the 12" water main necessary to provide fire flow to serve the proposed development. South Garland Boulevard Associates, LP has hired and engineer to prepare plans for the construction of this water main. The total construction cost of water main improvements associated with this project is approximately \$692,000 including both on and offsite improvements. The total anticipated infrastructure improvements (Street, Drainage, Water, & Sewer) is approximately \$2.5 million.

DISCUSSION

The proposed cost share will be to upsize the required 8" water main to a 12" water main from Razorback Road (approximately 1,100 ft) and extending the 12" water main to Stadium Drive (approximately 545 ft) along Indian Trail. This upsizing and main extension will replace the existing 12 inch main on the north side of MLK which is in poor condition. Recently, the existing 12" has had numerous breaks that interrupted service and traffic in the area, the main is also exposed in the College Branch, which increases the probability of damage.

The City would benefit from the cost share by utilizing the developer's contractor who will already be onsite performing water line installation. A bid waiver is requested since this cost share is greater than \$20,000.

AN ORDINANCE WAIVING THE REQUIREMENTS OF FORMAL COMPETITIVE BIDDING AND APPROVING A COST-SHARE AGREEMENT WITH SOUTH GARLAND BOULEVARD ASSOCIATES, LP IN THE APPROXIMATE AMOUNT OF \$98,949.00 FOR THE UPGRADING OF AN EIGHT-INCH WATER MAIN TO A TWELVE-INCH WATER MAIN ALONG INDIAN TRAIL FROM RAZORBACK ROAD TO ROSE AVENUE AND THE CONSTRUCTION OF A TWELVE-INCH WATER MAIN FROM ROSE AVENUE TO STADIUM DRIVE

WHEREAS, South Garland Boulevard Associates, LP, has hired an engineer for the design and a contractor for the construction of an eight-inch water main along Indian Trail to serve an approved large-scale development (LSD 12-4052 Park Green Collegiate View); and

CONTRACTUAL AGREEMENT

This Agreement, made and entered into this ______, by and between the City of Fayetteville, Arkansas and <u>South Garland Boulevard Associates, LP, 3 E. Stow Road,</u> <u>Marlton, New Jersey 08053</u>, Witnesseth:

WHEREAS, <u>South Garland Boulevard Associates</u>, <u>LP</u>, has hired an engineer for the design and a contractor for the construction of a 8" public water main along Indian Trail to serve their project, Development LSD 12-4052 Park Green Collegiate View; and

WHEREAS, there is an existing 12" water main to the west of this property on Razorback Road Lane and a proposed 12" water main on Stadium Drive. <u>South Garland</u> <u>Boulevard Associates, LP</u> will be connecting to this line; and extending a 8" main east 1,100 feet to as part of the required infrastructure for this development; and

WHEREAS, it will benefit the City of Fayetteville to upgrade this 8" water main to a 12" water main from Razorback Road (approximately 1,100 ft) and extend the 12" water main to Stadium Drive (approximately 545 ft) along Indian Trail. This upsizing and main extension will replace the existing 12 inch main on the north side of MLK which is in poor condition. Recently the existing 12" water main has had numerous breaks that has interrupted service and traffic in the area, the main is also exposed in the College Branch, which increases the probability of future damage.

NOW, THEREFORE, the City of Fayetteville and <u>South Garland Boulevard Associates</u>, <u>LP</u> agree as follows:

- 1. Upon the City Council and/or the Mayor approving the Water Main Cost-Share, the City of Fayetteville agrees to:
 - A. Pay for 100% of the actual documented construction costs for the upsizing to an 12" main from Razorback Road to Rose Ave along Indian Trail.
 - B. Pay for 100% of the actual documented construction costs for extending the 12" main from Rose Ave to Stadium Drive along Indian Trail.
 - C. Pay a maximum-not-to-exceed cost of <u>\$98,949.00</u> for the afore mentioned water main construction as was provided by <u>South Garland Boulevard</u> <u>Associates, LP</u> engineer and made a part of this agreement.
 - D. Reconsider the costs if the future and actual construction costs exceed the maximum-not-to-exceed amount that was furnished by <u>South Garland</u> <u>Boulevard Associates, LP</u>. The contractual agreement shall be required to be reevaluated and re-approved by the Mayor and/or City Council as appropriate prior to proceeding with construction.

- E. Make all efforts to provide payment to <u>South Garland Boulevard</u> <u>Associates, LP</u> within thirty (30) days after receipt of the invoice(s) but cannot guarantee the thirty day schedule.
- 2. <u>South Garland Boulevard Associates, LP</u> agrees to:
 - A. Provide the necessary and normal project management, inspection, and testing as necessary for a complete and acceptable water main installation.
 - B. Provide a copy of the invoice(s) from the Contractor and a completed lien waiver executed by the Contractor upon acceptance of the water main installation.
 - C. Not proceed with the proposed construction unless/until the proposed contractual agreement is approved by the City Council and/or the Mayor.
- 3. It is further understood that the contract for construction is between <u>South Garland</u> <u>Boulevard Associates, LP</u> and his Contractor and that the City has no contractual obligation with either the Contractor or the Engineer. The City's only obligation shall be to participate in a contractual agreement with a not-to-exceed amount of <u>\$98,949.00</u> for the water main upgrade and extension.




