Old Square, Inc. agrees to lease the north end of the basement of 26 West Center (approximately 3,500 square feet) to the City of Fayetteville for an annual rent of Nine **Thousand Dollars (\$9,000.00)** to be paid monthly at the first business day of each month beginning March 1, 2013 in the amount of **Seven Hundred Fifty Dollars (\$750.00)**

The City of Fayetteville agrees to lease approximately 3,500 square feet in the north end of the basement of 26 West Center from Old Square, Inc. and pay an annual rent of **Nine Thousand Dollars (\$9,000.00)** to be paid monthly on the first business day of each month beginning March 1, 2013, in the amount **Seven Hundred Fifty Dollars (\$750.00)**.

Old Square, Inc. shall be responsible to pay all building utilities. The City of Fayetteville agrees that the space it has rented will be used as storage space for City of Fayetteville records or property. Old Square, Inc. agrees to allow access to the City of Fayetteville records or property as needed by City personnel.

The City of Fayetteville shall not sublet any of this space without the prior written approval of Old Square, Inc.

The initial term of this Lease shall be two years (from March 1, 2013 until February 28, 2015). The City of Fayetteville shall have the right to renew this Lease for up to two additional years, but the annual rental (to be paid in future equal monthly payments) shall be increased to Nine Thousand Six Hundred Dollars (\$9,600.00).
